ACCORDING TO THE FLOOD INSURANCE RATE MAP THAT IS CURRENTLY IN EFFECT, THE BUILDING IS LOCATED IN FLOOD ZONE AE FLOODWAY, BASE FLOOD ELEVATION 19.6', (NAVD 88), AS SHOWN ON MAP NUMBER 13051C0019F, EFFECTIVE DATE SEPTEMBER 26, 2008. THE NAVD 88 HEIGHT IS COMPUTED BY APPLYING THE VERTCON SHIFT VALUE (-0.91) TO THE NGVD 29 HEIGHT.

THE BENCH MARK USED WAS ESTABLISHED USING GPS MEASUREMENTS. THE SQUARE FOOTAGE OF THE ENCLOSURE (GARAGE) IN SECTION A8.a IS APPROXIMATE. THE ELEVATION IN SECTION C2.a IS FOR THE ENCLOSURE (GARAGE) FLOOR. THERE IS LIVING SPACE ABOVE THE ENCLOSURE (GARAGE). THE ELEVATION IN SECTION C2.e IS FOR THE TOP OF PLATFORM FOR THE AIR-CONDITIONING COMPRESSORS.

THE SUBDIVISION PLAT REQUIRED MINIMUM FINISHED FLOOR ELEVATION IS 19.5' (NGVD 29).
